

3rd National Conference on Pharmacy Practice"Telemedicine: opportunities and Challenges"- Role of Pharmacist" at SGT University

Special Report

On Saturday March 18th 2023, SGT College of Pharmacy, SGT University, organized 3rd National Conference on Pharmacy Practice on the theme "Telemedicine: opportunities and Challenges"-Role of Pharmacist" for the B. Pharm., M. Pharm., Pharm D., Diploma in Pharmacy and Ph.D. Students including professionals from Industry, Research and Academics from all over the country.

The conference was sponsored by Science and Engineering Research Board (SERB)-Department of Science and Technology (DST, Government of India) in association with Indian Pharmacy Graduates' Association (IPGA).

SGT College of Pharmacy, SGT University, Gurgaon and Haryana is duly approved by State Government, University Grant Commission (UGC), New Delhi - MHRD and Pharmacy Council of India (PCI) - MHFW, Ministry of health & Family Welfare.

SGT college of Pharmacy was started in 2015 to offer B. Pharmacy, B. Pharmacy (Practice) and D. Pharmacy programs. Lately Pharm D (Doctor of Pharmacy) & M. Pharm Program in Quality Assurance, Pharmacology, Pharmacy Practice, Pharmaceutics, Pharmacognosy and Pharmaceutical Chemistry have been stared to train students in specialized area of research.

The concept behind organizing the "3rd National Conference on Pharmacy Practice" was to bring together the professionals from Hospital Pharmacy, Community Pharmacy, Clinical Pharmacy, Industry, Research, Academics, Regulatory and other sectors of Pharmacy profession on a common platform to accomplish the following aims and objectives:

- To understand the current status of Pharmacy Practice in India.
- To enhance the clinical knowledge of Pharmacist.
- To promote Telemedicine.
- To emphasize importance of Telemedicine.
- To understand opportunities and challenges of Telemedicine.

Chief Guest of the event Dr Montu M Patel and other dignitaries were felicitated by Hon'ble Chairman Shri Man Mohan Chawla and Pro Chancellor Prof. (Dr.) R.K. Sharma. Prof. (Dr.) Vijay Bhalla, Dean, SGT College of Pharmacy in his welcome address thanked all the dignitaries for sparing their valuable time to make this event a grand success.

SGT University officials, Pro-Chancellor Prof. Rakesh Kumar Sharma, Vice Chancellor (Officiating) Prof. (Dr.) Vikas Dhawan and Pro Vice-Chancellor Prof Atul Nasa were also present during the conference to welcome the dignitaries and students and addressed the gathering. The event was started by auspicious lamp lighting to mark the commencement of conference.

Dr. Montu M Patel noted in his Keynote that Telemedicine holds great potential for reducing the variability of diagnoses as well as improving clinical management and delivery of health care services worldwide by enhancing access, quality, efficiency, and cost-effectiveness. Furthermore, these platforms are in line with the government's vision of 'Digital India,' and are required to address situations caused by pandemics such as Covid-19. In his lucid talk he quoted, Time alone will tell that Telemedicine is a "forward step in a backward direction" or to paraphrase Neil Armstrong "one small step for IT but one giant leap for Healthcare".

Dr. S. Eswara Reddy emphasized that telemedicine is now the most innovative use of technology in health care. In a country like India, where last-mile connectivity to health care is a problem due to the country's growing population. Telemedicine is the ability to interact with patients via video conferencing from a distance. This enables super specialty consultations to be provided at a fraction of the cost. In his talk, he conveyed a note that how "By swiping and tapping on a phone screen, a patient can quickly find in-network brick and mortar doctors by specialty, name, or facilities, such as an urgent care centre, pharmacy, or hospital". He also discussed the proposed regulations on e-pharmacies.

Dr. Pramil Tiwari highlighted about role pharmacist in telemedicine. In his talk he stressed on need for the action plan on the telemedicine. Dr. Tiwari in his concluding talk said that it can be a game changer for people in the rural areas who do not have easy access to medical specialists located in cities.

Dr. Kalpana Jaswal, presented on the topic-"Pharmacist role in Telepharmacy". She discussed that a well-developed system, can change the practice of pharmacy that is beneficial to both the rural communities and the hospitals or retail pharmacies that deliver these services.

A panel discussion was also organized for the participants which was Moderated by Mr. Rajiv Gulati, Advisor, SGT University, Haryana very efficiently. Dr. Deependra Singh, Dr. Sanjeev Sharma, Prof Vijay Sharma, and Mr Kalhan Bazaz as panellist clarified various doubts and myth on telemedicine and discussed the future of telemedicine in India and globally.

Prof Raj K Shirumalla, Chairman Scientific Services presented the report on online poster presentation, he informed that more than 130 posters under four categories were presented and evaluated by the learned Poster Evaluators. Chief Guest and other dignitaries released the Book of Abstracts during the inaugural session. 

Special Article

1. Introduction: Standard Operating Procedures (SOPs) are an integral and important part of the routine operations in the pharmaceutical industry, and each department should have their own SOPs. It is a set of step by step instructions prepared by an organization to carry out all activities under defined conditions. In other word it is a set of detailed instructions, written document which describes the regularly recurring operations relevant to the quality of the investigation. In 2

Pharmaceutical Standard Operating Procedure (SOP) is a tested, verified, approved, and documented way of executing operations that form the pharmaceutical industry's basis. It provides step-by-step guidance for the personnel to perform a specific process. SOPs describe technical as well as fundamental operational program of an industry that would be managed under every department. It also indicates the purpose of the operation, the equipment and materials required, how to perform the set-up and operations required for the process, how to perform the maintenance and shutdown operations carried out by the worker, a description of safety issues, trouble-shooting and a list of spare parts and where to find them, illustrations, and checklists.^{2,3}

2. Purpose: The main aim of SOPs is to achieve quality output, efficient working and uniform performance. SOPs help employees to carry out complex routine operations without error. It is against regulatory requirements to perform operations without properly developed, approved and controlled SOPs. The perfect way to ensure safe and efficient operations is to strictly follow Standard Operating Procedures. SOPs provide a framework for each department within the industry to follow when performing day to day activities and they can be utilize as a training tool for new employees.^{1,3}

It also ensures that all employees are performing tasks in the uniform way, which is a required to get expected output from the process. When all workers perform their work constantly, it becomes possible to run controlled experiments to test the impact of changing various process parameters.⁴

- 3. Scope: This article will look at the definition of SOPs and their importance in the pharmaceutical industry. SOPs need to provide clear instruction to the end user on how to perform a task, and sufficient detail to allow the task to be executed in a consistent and uniform manner by all end users. Various processes are complex in nature and they required right balance between too little and too much detail. If there is too little detail this increases the potential for the end user to follow their own way of doing things. On the other hand, too much information and excessive detail increases the risks that the end user has difficulty understanding and following the steps on a daily basis, leading to errors and mistakes.^{2, 3}
- 4. Benefits: SOPs provide continues improvement of standards of service, and provide evidence of commitment towards protecting patients. Additional advantages are:
- SOPs minimizes variation and promotes quality through consistent implementation of a process or procedure within the organization;
- SOPs help to provide quality and consistency of service;
- It minimizes opportunities for miscommunication;
- Help to ensure that good practice is achieved at all times;
- Provide an opportunity to fully utilize the expertise of all team members;
- It reduced work effort, along with improved comparability, credibility, and legal defensibility.
- Enable pharmacists to delegate;
- Help to avoid confusion over who does what (role clarification);
- o Provide advice and guidance to part-time staff;
- They are useful tools for trained new employees in organization;
- o Provide a contribution to the audit process.
- When writing or updating SOPS, remember these important points to avoid complexity.

5. Preparation of SOPs: 5, 6

SOPs should be prepared in a concise, clear, step-by-step, easy-to-read format. The information should be unambiguous and should not be complicate. The term "you" should not be used, but implied. The process should not be redundant, or overly lengthy. Make it as simple and short. Instructions should be provided clearly to minimize any doubt as to what is required. Also, use a flow chart to illustrate the process being described. In addition, follow the style guide used by industry, e.g., font size and margins. A generalized format is as follow:

5.1 Title or Header of SOP: A unique title shall be given to each SOP. The title shall be comprehensive in short. The title clearly identifies the activity or procedure, SOP identification (ID) number, effective date and/or next revision date, and the signatures and signature dates of those individuals who prepared, reviewed and approved the SOP.

SOP Author & Reviewer: SOPs should be prepared and reviewed by one or more individuals with appropriate training and experience with the process. Ensure that the author of the SOPs is the employee who performs the task and/or understands it well while at the same time avoids going into excessive detail. SOPs should be also systematically reviewed on a periodic basis, e.g. every 1-2 years, to ensure that the policies and procedures remain current and appropriate, or to determine whether the SOPs are even needed. The reviewer should ensure that the balance between too little and too much detail is assessed. The finalized SOPs should be approved as described in the organization's Quality Management Plan.

- 5.2 Content of the SOP: A Table of Contents may be needed for quick reference, especially if the SOP is long, for locating information and to denote changes or revisions made only to certain sections of an SOP.
- 5.2.1 Objective and purpose: Mention the intended purpose of the SOP in this section. Objective justifies the need of that SOP.
- 5.2.2 Scope: Indicate the application of the SOP in this part. It shall describe the extent of areas covered by the SOP.
- 5.2.3 Responsibility: Mention the responsibilities in brief, but with clarity on ownership of individuals / departments in this column.
- 5.2.4 Distribution: List of individuals/ departments to whom a controlled copy of the approved SOP shall be issued.
- 5.2.5 Definition of Terms: The new/ uncommon terms those are used in the SOP shall be defined in this section.
- 5.2.6 Abbreviation: Write full name of all Short forms used in SOP.
- 5.2.7 Procedure Outline of the logical steps & step by step instructions to be carried out to complete the process and to fulfill the purpose of the SOP.

- SOP text shall be written in simple and clear language in font style "Times New Roman", with a Font size '12' and space between lines shall be 1.5 lines.
- All SOP shall be written in the English language.
- Frequency of process should mentioned if applicable.
- Bold letters shall be used for heading and subheadings.
- Wherever required, give example or attachment for more clarification. Each step of the activities / operations shall be explained stepwise.

5.3 Footer Section:

Footer shall consist of 4 columns of Prepared by, Reviewed By & Approved By.



How to improve quality of SOPs: 2, 5, 6

Maintain Simplicity: Long, complex SOPs can be difficult to follow. Strive to keep your SOPs simple and easy to use while still ensuring all important steps are included.

Photos/ Drawings/Flow Charts: Prepare your SOPs easy to understand by including photos, drawings and flow charts. Humans prefer visuals to text, so it makes sense to use more visual information to explain complicated information. Include illustrations, diagrams, flowcharts or other visual aids that can help with understanding.

Reduce the number of people involved in the tasks: The more people you have involved in a task, the more chance there is for mistakes. By reducing the number of people involved in a task, you can greatly improve how quickly it can be done and ensure that it's done correctly.

Test and verify SOP function: Once the SOP is drafted, test it with those individuals who will be use it routinely. Have them follow the SOP from beginning to end to ensure the information is clear, that all the required steps are included and are in the correct sequence.

Protect what you have simplified: During the review process don't let people put in additional steps or put back in what you've taken out without adequate justification. Exercise caution when updating SOPs as the corrective action or preventative action (CAPA) for deviations.

Review and revise, as needed: Once the SOP has been in use for several weeks, ask for responses from those with direct experience using it. Ensure that the SOP is clear, accomplishes its purpose and is easy to read and use. Revise based on the feedback you receive.

Keep your SOPs up to date: Prepare SOPs in line with current requirements is very important. Without periodic review of SOPs and regular updates, they can quickly become out-of-date. SOPs should be reviewed at least every two to three years. Some SOPs may need to be reviewed on a more frequent basis, especially if the process they explain is updated or changes.

Conclusion: SOPs play a great role in communication for all levels of the organization. As SOP preparation is a critical step so each pharmaceutical industry must have experts that can create accurate process-driven SOPs in line with relevant regulatory regulations which ensures safety, efficacy and quality of the product. However currently, pharma industry facing challenges in managing and controlling the SOP process. A good system forces employee to think through processes and examine how procedure might influence product, personnel, production, and equipment. This attitude encourages employees to think about how process change may affect other functional areas.




