Women in Pharmaceutical healthcare and Education as Leaders

The role of women in pharmaceutical industries and education has evolved significantly over the years. Traditionally, the field of pharmaceuticals was predominantly male-dominated, with limited opportunities for women. However, with changing societal norms and increased emphasis on gender equality, women have made significant strides in both the pharmaceutical industry and the field of education.

Recognizing the achievements of women has a huge impact on the development of our pharmacy apprentices and future pharmacy leaders, and presents opportunities for aspiring pharmacists. Women have made significant strides in the field of pharmacy and have become an integral part of profession. Over the years the representation of woman in pharmacy has steadily increased.

Pharmacy is a professional field and yet there remains a considerable gender disparity in pharmacy leadership and ownership. Women often face gender-specific challenges, including a lack of recognition, support, and mentorship opportunities. There is a need to shine a light on the changing demographics of pharmacy. Since the 90s, the majority of pharmacy students have been women. The impact female pharmacists have on their patients - whether it's in a retail pharmacy, small community, hospital, or within academia cannot be underestimated.

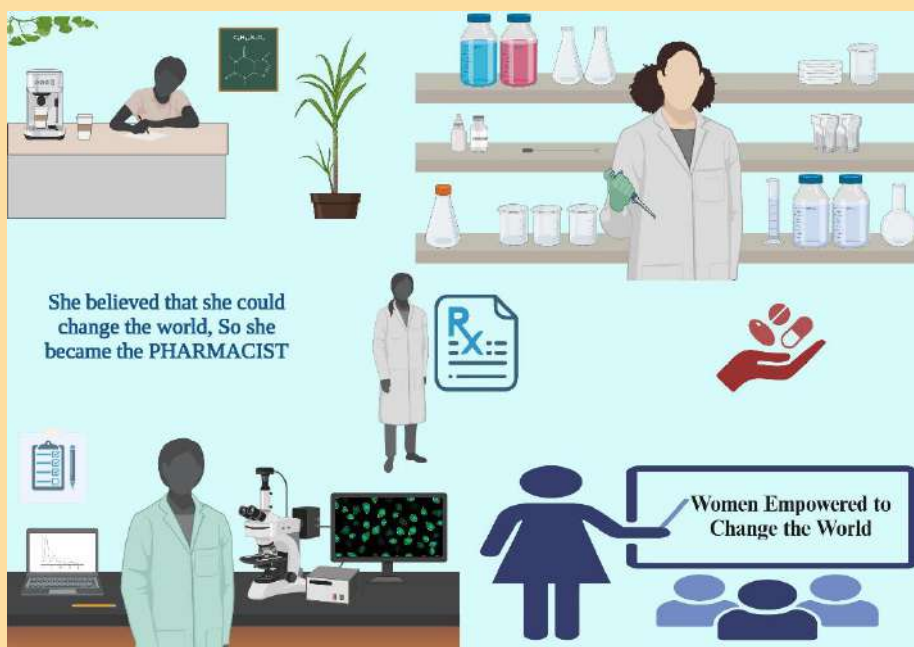
Women are a force to be counted with in the pharmacy field. In the health sector, women represent 71% of the global workforce and 59% of all medical, biomedical and health science degree graduates. However, the issues persist with lower participation of women in leadership, relative to their proportion in the workforce. Barriers include reduced capacity due to career disruption and external responsibilities; credibility assumptions around women in leadership and perceived capability and confidence.

Women in Pharmaceutical healthcare and Education as Leaders

Early career male and female professionals progress in similar pace but on long run women are five times more likely to have family related career disruptions, profoundly impacting on career progression. With changing scenario, this statistics has also changed with more committed involvement of women in the field followed by result oriented rewards.

Women make up 57.5 percent of the pharmacy workforce and are bridging the gap in management and leadership positions. Women have pursued pharmacy education and training, earning doctor of pharmacy (Pharm D) or equivalent degrees. They have taken on leadership roles in pharmacy organizations at local and national levels. They serve as presidents, board members and committee and chairs advocating for the profession and patient care. Woman pharmacist works in various health care settings, including hospitals, community pharmacy, ambulatory care clinics and contributes to interdisciplinary health care team. Woman pharmacists are actively involved in pharmaceutical research, drug development, clinical trials and pharmacotherapy research.

They contribute to advancing the understanding of medications and improving patient outcomes. Woman pharmacist advocate to patient centred care, medication safety and access to health services. They have also ventured into entrepreneurship opening their community pharmacy and consulting practices, contributing to health care access and innovation. Woman pharmacists serve as mentor and educator, guiding the next generation of pharmacist and pharmaceutical scientist.



Women in Pharmaceutical healthcare and Education as Leaders

Women can create the change they want to see as women are gaining more recognition for their contributions to the pharmacy profession. Women pharmacists are moving the profession forward and using their voice to help others to make sure that pharmacists have a central role as healthcare providers. It is estimated that by 2030, a sizeable part of the global pharmaceutical workforce will be women professionals. In India, the number of women pharmacists is rising up in all the sectors including industry, hospital, R&D, academia and trade. But, they face challenges when they push to reach top positions and many of them become unable to achieve their goals as leaders in businesses or in institutions.

Women as pharmacists bring a unique blend of expertise, empathy, and dedication to the healthcare sector. Their influence extends far beyond the confines of the pharmacy, positively impacting the lives of countless individuals. As they continue to break barriers, innovate, and believe for patient well-being. Their contributions remind us that gender should never be a barrier to achieving excellence in any profession.

In the pharmaceutical industry, women have made notable contributions in various roles, including research and development, clinical trials, manufacturing, marketing, and management. They have played a crucial role in the development of new drugs, ensuring the safety and efficacy of medications, and improving patient care. Women have also excelled in leadership positions, overseeing large pharmaceutical companies and driving innovation in the industry. Their expertise and contributions have led to advancements in healthcare and the development of life-saving medications. There are few success stories encouraging more females to join the entrepreneurship bandwagon has been a common topic even before women-led startups became a thing. Some women dreamt about the modern-age we are in today and worked towards bringing this change. Their journey was very tough and their experiences have been useful for others. Kiran Mazumdar-Shaw founded India's largest listed biopharmaceutical firm by revenue in 1978 called Biocon. She encountered many difficulties due to her inexperience, femininity, and unproven business concept. Funding was a significant problem because no bank wanted to lend her money. She refused to give up and now she is known as India's first Biotech queen. Meena Ganesh founded India's largest outside-of-hospital healthcare company called Portea Medical to offer care at home.

Women in Pharmaceutical healthcare and Education as Leaders

Her advice to other women entrepreneurs is the road between starting up and reaching great heights requires unwavering commitment and a lot of resilience to overcome the challenges.

Founder of Niramai, Dr. Geeta Manjunath explains that a tragedy in her family turned her focus to breast cancer. Learning something new and trying to solve problems have been motifs in Manjunath's journey. Only few people turned up for the first breast cancer screening session organized by Niramai, the team still kept going and currently they do thousands of screenings every month. Preetha Reddy, the Managing Director of Apollo Hospitals, not only established herself as a pioneer in India's healthcare sector but also played a significant role in various initiatives, one of which was helping the Indian government introduce the NABH.

In terms of education, women have increasingly pursued careers in pharmacy and pharmaceutical sciences. They have excelled in pharmacy schools, securing academic positions, and contributing to research and teaching in the field. Women have also been at the forefront of pharmaceutical education, training the next generation of pharmacists and pharmaceutical scientists. Their expertise and mentorship have been instrumental in shaping the future of pharmaceutical education and research.

Despite these advancements, challenges and gender disparities still exist in the pharmaceutical industry and education. Women continue to face barriers in career advancement, and representation in leadership positions. Efforts are being made to address these issues and promote gender equality in the field. Various organizations and initiatives are working towards fostering an inclusive environment, providing mentorship opportunities, and advocating for equal opportunities for women in the pharmaceutical industry and education.

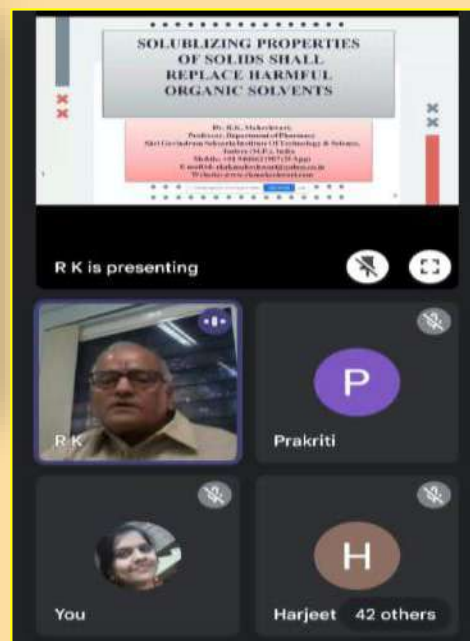

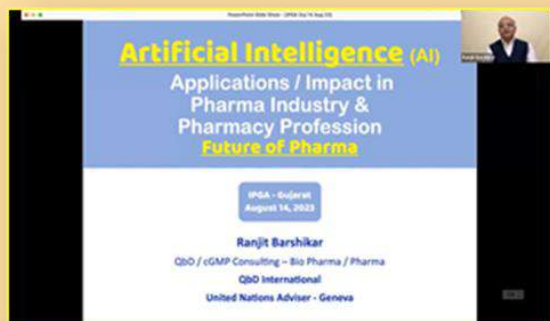
